## PLEASE CONTACT THE INQUIRY PANEL BY 22nd MAY 2026

In March 2026 the Government announced the launch of the long fought for Orgreave Inquiry. This is an independent statutory inquiry set up by the Government to understand more about the events at the Orgreave Coking Plant on 18th June 1984, associated with the prosecutions of those arrested on the day.

The Inquiry Panel need information and evidence from former miners, their families, witnesses, organisers, supporters and anyone else connected with the Miners' Strike who can help to provide information to the Orgreave Inquiry about what happened at Orgreave on 18th June 1984.

The Inquiry Panel deadline date for information is **22ND MAY 2026**. The Orgreave Truth and Justice Campaign (OTJC) has asked the Inquiry Panel to extend this deadline and help people to submit their information.
